1.1 Introduction

1.1 Introduction

You can use the ETAS License and Download Portal to create and manage licenses and to download software packages:

- Generation and tracking of software licenses
- Transparency of license terms, such as maintenance expiry dates
- Flexible login capacity
- Download of purchased software packages, Service Packs, Upgrades and Hotfixes
- Support for several license-related transactions, both before and after license generation, such as...
 - Activation
 - Return
 - Rehost
 - Consolidation
 - Viewing and printing Entitlements

1.2 Access to the ETAS License and Download Portal

a) Access to manage your ETAS Licenses

There are several options to enter the portal:

With Username and Password

You will be enabled to see and manage all Activations in all the Entitlements assigned to your account (e.g. for a tool coordinator responsible for several Entitlements)

With Entitlement ID

Will allow you to see and manage all Activations in the entered Entitlement (e.g. for a company with only one Entitlement)

1.2 Access to the ETAS License and Download Portal

With Activation ID

b) Enable Downloads in the Portal

- If you already have a valid ETAS FNO Customer Portal User with Password, you can extend your User to access also the Downloads in the Portal (valid Activation ID or Entitlement ID is needed).
- If you do not have a valid user and you want to evaluate ETAS Software you can use the **Product Evaluation** link to register yourself and select an available Evaluation Product.
- If you only need access to the ETAS Non-Public Downloads you can use the **Access to Non-Public Downloads** to register yourself.
- If you are already registered for Evaluations or for Downloads you are automatically also enabled to access the Non-Public Downloads.

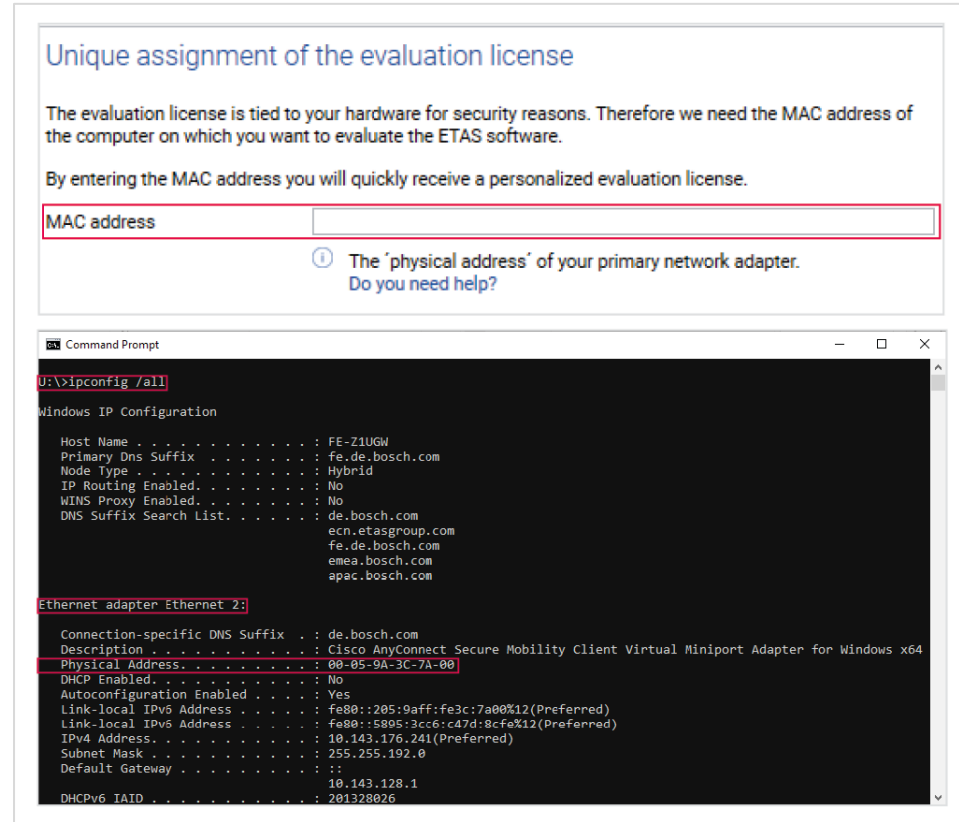

Note: This step is only required if the software uses FlexNet Publisher license technology. Otherwise, you will not see this field.

You will be asked to enter the MAC address of the computer on which you want to evaluate.

How to determine the MAC address of the computer:

1. Open the command prompt window.
2. Enter the command "ipconfig /all".
3. Search for the parameter "Physical Address" for your Ethernet adapter and take note of the specified value (in this example: 00-05-9A-3C-7A-00)

1.4 License Technology

1.4.1 Difference between FlexNet Publisher and FlexNet Embedded

When viewing licenses or entitlements in the license portal it is important to distinguish between the license types. The column “type” shows an icon indicating the technology used.

FlexNet Publisher (FNP)

- A white “C” on red background indicates a certificate based license, which means it is a FlexNet Publisher based license.
- Activation of a **FNP** license is done using the Activation ID in the **ETAS License Portal**.
- FNP licenses are then saved as *.lic files which are deployed either onto the target PC or onto a license server. The license file itself contains the license information in readable format.

FlexNet Embedded (FNE)

- A white “E” on green background indicates a FlexNet Embedded license
- Activation of a **FNE** license is done using the Activation ID in **ETAS License Manager tool** on the target PC
- FNE licenses are not stored in readable files but in a so called “trusted storage”. This is a data storage on the customer’s device which is secured against manipulation or copying using additional measures.
- Therefore ETAS License Manager offers either online activation or offline activation. The latter can be used if the device is not connected to the internet

1.4 License Technology

License Technology change

- ETAS has used FlexNet Publisher technology for many years. From September 2020 onwards, FlexNet Embedded will be introduced. New software releases will only be shipped with FlexNet Embedded technology implemented in future.
- FlexNet Publisher license technology will be further supported according to the terms and conditions for existing software versions

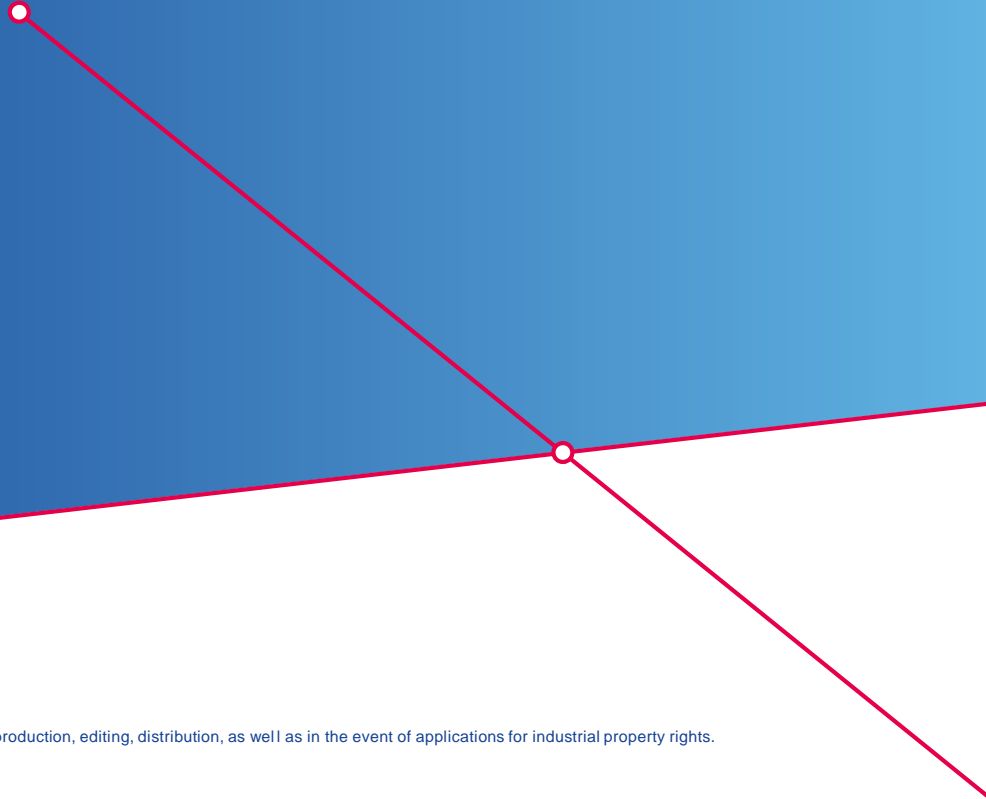
License Right Changes

- ETAS FNP License rights are stored in *text* license files
- ETAS FNE License rights are stored in in Trusted Storage

End User Interaction Changes

- With FlexNet Publisher, an end user is expected to run the license activation utility. Typically this involves typing in an activation code, installing a license text file or interacting with an application's installer.
- With FlexNet Embedded, there is no expectation of a user interacting with a user interface. The core toolkit makes no assumptions about a command prompt or window manager being available. A device can power up, possibly contacting a back-office server, and checks its license rights to determine the behavior, functionality, capacity, etc., that the device supports.

2.3 License Lifecycle

Licenses have a lifecycle that extends beyond activation and fulfillment (license delivery). Different events at your end (e.g. purchase of new machines, crash of a hard disc...) can affect the lifecycle. The following kinds of license change management are supported by the ETAS License Portal:

- Retrieve an existing license key (e.g. if the old one is lost due to accidental deletion etc.). See [Retrieve License Key](#) for details.
- Specify a new license server Host ID, a new MAC address or a new Windows User Name for a license (e.g. when you replace a computer or assign a license to another user). See [Rehost](#) and [Return](#) for details.
- Consolidate existing licenses into one license file for easier management. See [Consolidation](#) for details.

2.4 Upgrades



Activations derived from product upgrades:

- If your licenses are covered by a valid maintenance contract, you can receive product upgrades. Upgrading from one major version to another (e.g. from INCA V6.x.x to INCA V7.x.x) will require the generation of a fresh license key as the keys are bound to the product version.
- When the upgrade is performed, ETAS will create a new activation to provide a license for the new product version. And it will be automatically activated for the Host of the previous license.
- If old version licenses have not been activated and a upgrade is done, you can activate the license for the new version as described on page 11-15
- Such line items can be distinguished through a special icon:

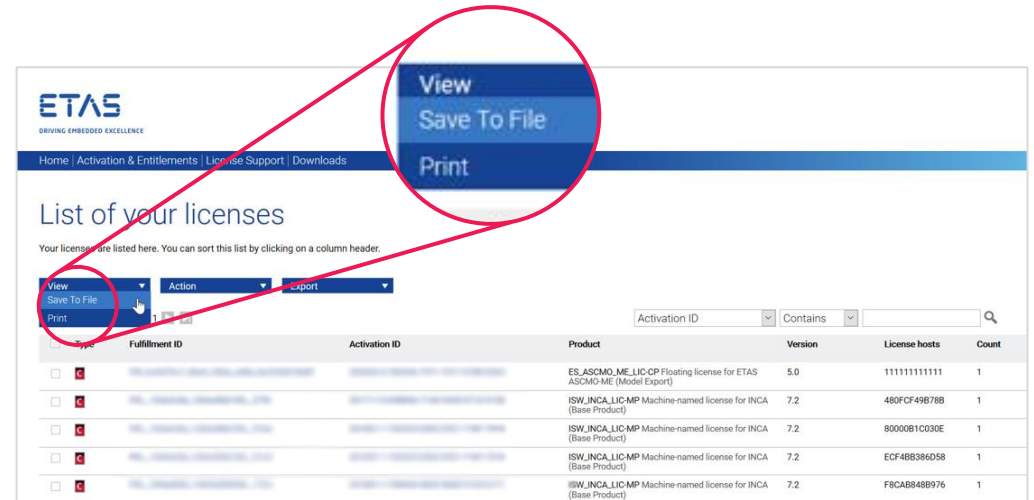
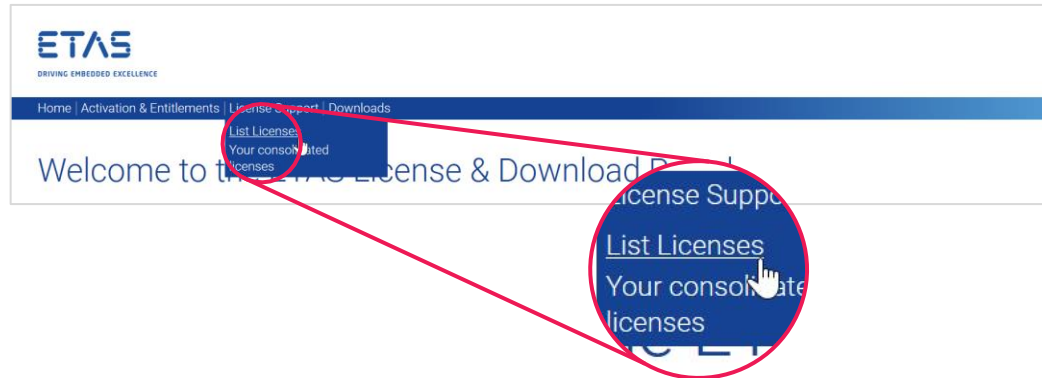

A rehost enables you to specify a new license server Host ID or MAC address for a license. This may be needed when you replace a computer.

A rehosted license has a new Fulfillment ID, but retains the original Activation ID.

If only some of the original fulfillments are rehosted, a second (new) fulfillment will be generated for the copies that are not rehosted with the original Activation ID.

E.g. this happens, if you split Concurrent licenses between two servers.

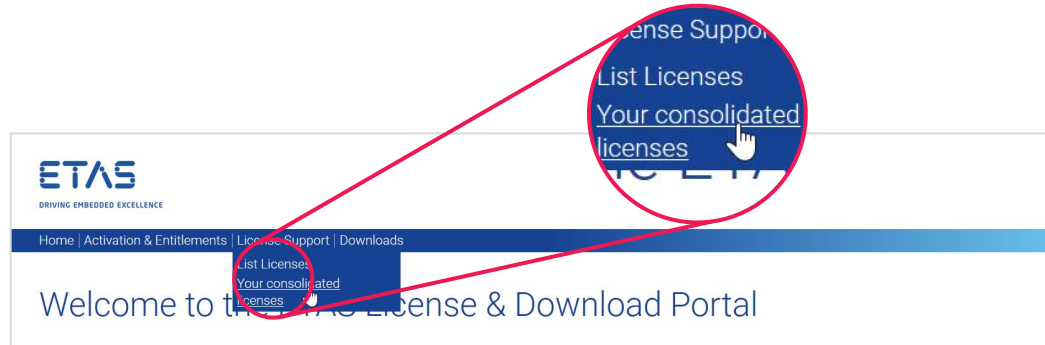

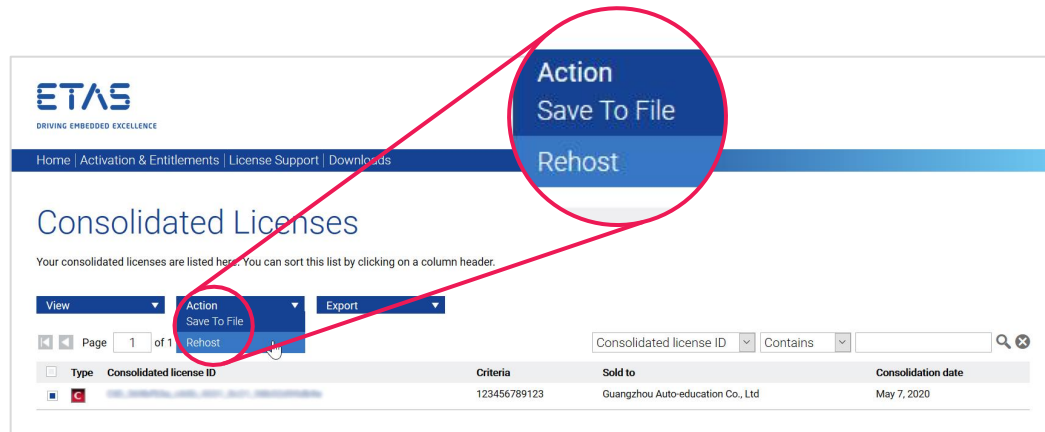

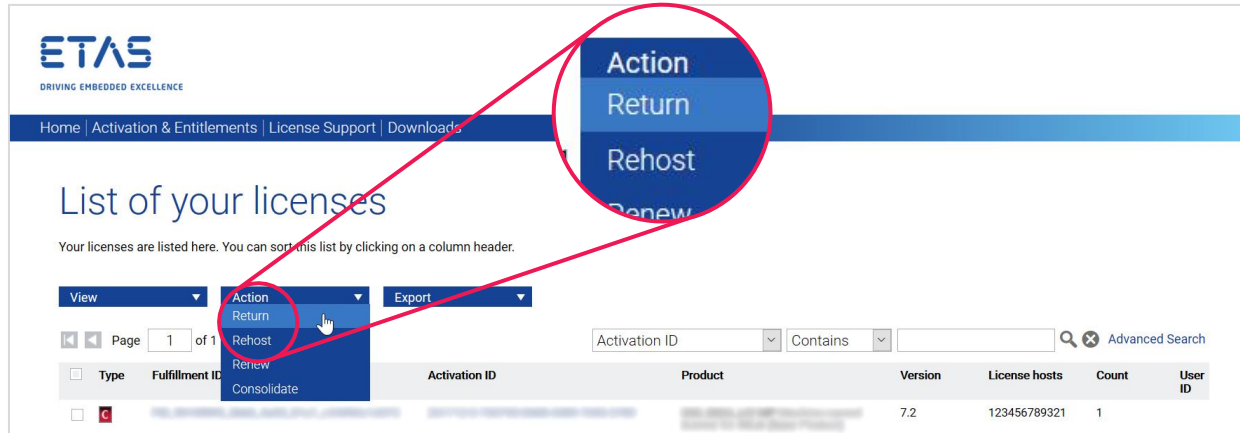

A return refers to the process of moving license rights from a user to another user. By returning a license the number of available copies in the ETAS License Portal increases by the amount of returned licenses, so a new license key can be generated.

- Go to **“Manage Licenses”**

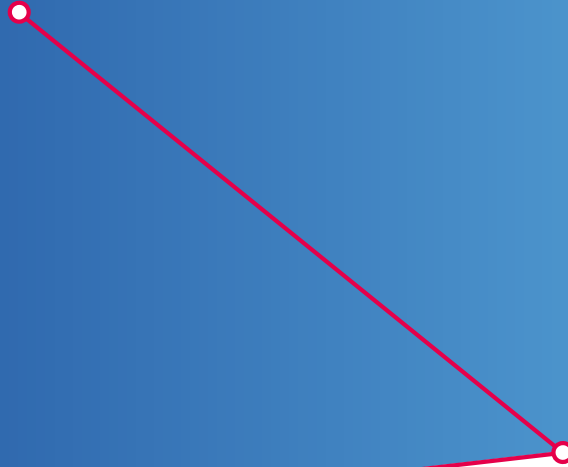

3.2 View and Manage Devices

A device is a hardware or software component that uses FlexNet Embedded to license its products. FlexNet Embedded devices connect to FlexNet Operations to manage their ownership, state, features, and more. Examples of devices are laptops running ETAS software or measurement devices (“blue boxes”).

A device is identified by a Device ID and its type. Device types are:

- Standalone Device
E.g: FlexNet Embedded device that connects to FlexNet Operations, which manages the device.
- Server
E.g: FlexNet Embedded server that communicates with FlexNet Operations to manage device ownership, state, and features for a collection of served devices.
(When a FlexNet Embedded server is used, its served devices connect with the FlexNet Embedded server rather than connecting directly to FlexNet Operations.)
- Served Device
E.g: FlexNet Embedded device that is managed via a FlexNet Embedded server. In FlexNet Operations, served devices are essentially read-only entities.




3.2 View and Manage Devices: Filtering the Devices List

To quickly reduce the size of the devices displayed on the Devices page, you can filter it by device type and activation status.

To filter the devices list

1. Hover the cursor over the filter icon to display the filter selection list.

3.2 View and Manage Devices: Searching for Devices

Existing devices can be easily located by performing a search on the Devices page. You can perform a simple search on a single attribute, or an advanced search on multiple attributes. For both searches, you can use the * wild card to match zero or more characters.

Simple Search

1. On the Devices page, click the drop-down list next to the filter icon and select the search criterion.
2. Type the search string in the text field next to the drop-down list.
3. Click Search.

Advanced Search

1. On the Devices page, click the + icon (next to the Search button) to open the Advanced Search window.

3.2 View and Manage Devices: Upload Capability Request

Whenever your end device cannot connect directly to the internet, this functionality becomes relevant.

Example: You use the “Offline Activation” or “Offline Return” in ETAS License Manager (LiMa). This page allows you to manually upload the data provided by LiMa.

The uploaded files are called “Capability Request” files.

To upload a Capability Request for a device:

1. Select “Devices” -> “Upload Capability Request” from the menu bar
2. Click “Browse...” and select the Capability Request on your local system. (The exact controls vary depending on the browser you are using.)
3. Click “Upload”

After the Capability Request has been processed, you can download a “Capability Response” file from the portal (look in your browser’s download area). This Capability Response file needs to be transferred back to the device where the Capability Request was created. The response is then processed in the respective dialog in ETAS License Manager.

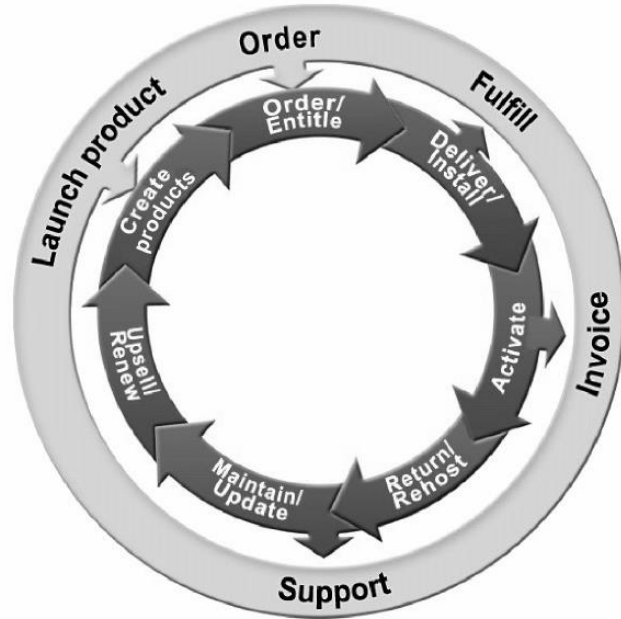

3.3 License Lifecycle



The delivery/installation and activation stages of the FlexNet Embedded license lifecycle are covered in this guide.

- Create Products
 - Create product definitions that are used to generate licenses
- Order/Entitle
 - Define a customer's rights to obtain licenses for your products
- Deliver/Install
 - Deliver the application software to the customer and install that software
- Activate
 - Deliver licenses to the customer
- Return/Rehost
 - Manage license transfers from one user or system to another
- Maintain/Update
 - Deliver software and license updates to the customer
- Upsell/Renew
 - Renew customer licenses, or sell the customer additional product functionality

3.4 Activation

- **Online Activation**

- The ETAS License Manager software (LiMa) generates a Capability Request for entitled features, then sends the request to FlexNet Operations via the Internet. FlexNet Operations sends a Capability Response to the device, which processes the response and places the license into trusted storage.
- No manual interaction with ETAS License & Download Portal is required

- **Offline Activation**

- The ETAS License Manager software (LiMa) generates a Capability Request file, which is manually transferred to a connected system from which it can be uploaded to FlexNet Operations. The Capability Response is downloaded from FlexNet Operations and transferred to the ETAS license management software (LiMa) for processing.
- Refer to section 3.2 - Upload Capability Request and Generate Capability Response in the ETAS License & Download portal

3.5 Return and Rehost

- **Offline Return**

- The ETAS License Manager software (LiMa) generates a Capability Request file, which is manually transferred to a connected system from which it can be uploaded to FlexNet Operations. The Capability Response is downloaded from FlexNet Operations and transferred to the ETAS License Manager software (LiMa) for processing.
- LiMa processes the Capability Response and the license is removed from the device. LiMa generates the confirmation file which needs to be uploaded to FlexNet Operations.
- After the upload of the Confirmation Response in FlexNet Operations, the license is available again for activation
- Online Return is not supported

- **Manual Return**

- If the customer PC is defect or lost, the customers should inform ETAS customer support for manual return processes

- **Rehost (only possible through return + new activation)**

- After the return process, the license can be activated on another device.

3.6 Migration

- **Online Migration**

- The ETAS License Manager software (LiMa) generates a Migration Request for entitled features, then sends the request to FlexNet Operations Service via the Internet. FlexNet Operations Service processes the response and places upgraded FNE licenses into trusted storage.

The old activation ID will become obsolete and a new activation ID is assigned during migration.

- No manual interaction with ETAS License & Download Portal is required

- **Offline Migration**

- The ETAS License Manager software (LiMa) in the offline PC generates a Migration Request file, which should be manually transferred to a PC which can connect to FlexNet Operation Service through the internet.
- The online PC uploads the request file into the Flexnet operation service through Lima, downloads the response file and transfers the response file to the offline PC
- The offline PC processes the response file, which will install the upgraded FNE license into the trusted storage
- No manual interaction with ETAS License & Download Portal is required

5.1 Entitlements

An entitlement represents what you, the customer, have the legal right to use; it is the right to obtain one or more licenses for a product. Think of an entitlement as an account, or a store of rights to use software, from which you can redeem licenses as needed. For example, let's assume you order 10 concurrent licenses of ETAS' Software's product, ASCET Rapid

Prototyping Version 6.0.0 You will be issued an entitlement for those 10 copies, specifying the duration of validity. Each entitlement is identified by a unique Entitlement ID, and contains one or more entitlement line items. See **“Activations”** for details.

5.2 Activations

Each Entitlement contains a number of Entitlement line items that can be activated, i.e. a license can be generated for them. The Activation maps to a single product, its license terms, the number of copies entitled, and other details needed to generate a license. Activations are uniquely identified by Activation IDs.

If an Entitlement line item has been activated, the license key for it has been created.

The ETAS License Portal will show activated licenses as fulfillments. See **“Fulfillments”** for details.

5.3 Fulfillments

Each time a license key is activated, a fulfillment is generated. The fulfillment contains information on the product, the hosts

and the date when it was created. It is identified by a unique Fulfillment ID.

5.4 Hosts

In order to activate licenses, information on the hosts/licensed devices has to be entered:

- Machine named license: a MAC address has to be provided
- User named license: a server host or server triad as well as a user name have to be provided
- Concurrent license: a server host or server triad has to be provided

If this data changes (e.g. due to a change in hardware or users), the license needs to be “rehosted”. This procedure is described in [Chapter 2.7](#) of this manual.

5.5 License Keys

The license determines how, when, and where you can use a licensed product such as ASCET Rapid Prototyping. To ensure the correct usage of the license product, these information

are stored in digitally-signed, human-readable text files. This is called certificate-based licensing.

5.6 License Models

Machine named (PC Based)

- License needs to be managed by each user on his/her own
- License can be carried with the PC
- Exchanging the PC will require you to generate a new license first

Concurrent (Server Based)

- Easy and transparent license management by one server responsible
- License can be borrowed and carried with the PC if enabled
- License is available on each PC in the network
- Several users share a fix amount of licenses; availability of a sufficient amount of free licenses is not granted

User named (Server Based)

- Easy and transparent license management by one server responsible
- License can be borrowed and carried with the PC

- 100% availability for one specific user

5.7 Consolidating Licenses

Consolidating licenses will make it easier for you to manage your license files. Possible use cases are:

- A user has licenses both for the main product and the add-on
- A lot of users have User named licenses which refer to the same server
- Consolidated licenses can be rehosted in one step instead of several separate steps
- You can only consolidate licenses if they have the same MAC address

6.4 Trusted Storage

Trusted storage is a secure location bound to a particular device. In addition to its contents being encrypted, security features of trusted storage include:

- Binding, which detects if trusted storage has been copied to another device by using producer-defined system identity characteristics. When license rights are placed in trusted storage, a „fingerprint“ made of system characteristics is placed in trusted storage; when license rights are acquired, the stored fingerprint is compared to the current system's fingerprint to detect changes.
- Anchoring, which provides trust that trusted storage has not been deleted or rolled back to an earlier state on the same device. This prevents a device from restarting a trial license if trusted storage is deleted, for example. To achieve this, another stores a small amount of data in a location that is difficult to observe or access

6.5 License Models

Machine named (PC Based)

- License needs to be managed by each user on his/her own
- License can be carried with the PC
- Exchanging the PC will require you to generate a new license first

Concurrent (Server Based)

- Easy and transparent license management by one server responsible
- License can be borrowed and carried with the PC if enabled
- License is available on each PC in the network
- Several users share a fix amount of licenses; availability of a sufficient amount of free licenses is not granted

User named (Server Based)

- Easy and transparent license management by one server responsible
- License can be borrowed and carried with the PC
- License is available on each PC in the network
- 100% availability for one specific user
